The Welch Allyn CardioPerfect™ Ambulatory Blood Pressure Monitor Software is used to record, view, and print 24 hour ambulatory blood pressure tests. The system includes a database which stores the patient's demographics and medical information.

The types of PII collected in this system include patient demographics and medical information.

This PIA updates the PIA with the same name approved on 26 July 2012.

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

The privacy risks associated with the PII collected are unauthorized access and unauthorized disclosure of PII. Security safeguards (physical, technical, and administrative) are in place to mitigate these risks. The security safeguards are addressed in Section 3 below.

In the case of military personnel, the requested information is mandatory because of the need to document all active duty medical incidents in view of future rights and benefits.
