The Assessment Data Manager (ADM) software makes it easy to manage the assessment information obtained from the Achenbach System of Empirically Based Assessment (ASEBA) forms. The ASEBA is a comprehensive evidence-based assessment system developed through decades of research and practical experience. It assesses competencies, adaptive functioning, and behavioral, emotional, and social problems from age 1½ to over 90 years. The ADM software allows the user to quickly enter and score forms, create profiles and cross-informant comparisons, and save data. The software provides a variety of age-based entry and scoring modules.

The types of personal information about individuals collected in the same include patient demographic data and medical information.

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

The privacy risks associated with the PII collected include unauthorized access and unauthorized disclosure. There are security safeguards in place to mitigate these privacy risks. These security safeguards are outlined in Section 3d and 3f below.
