The CBORD® Group, Inc., Point of Sale (POS) System, incorporates several commercial products that facilitate cashless transactions for retail services to include cafeteria dining. The MICROS® 3700 offers robust point-of-sale and back-office operations, flexible reporting, and real-time business intelligence to increase efficiency, speed service and provide a better experience for the customers. It maintains all pricing, food menus, and sales data. The Odyssey PCS™ electronically tracks sales when customers (employees) use the pre-paid charge card associated with this application. The MICROS 3700 directly interfaces with the Odyssey PCS to enable real-time validation of the customer's declining balance on the pre-paid charge card. The pre-paid charge cards have numerical designations and are not associated with a specific individual.

The only personal information about individuals collected are the names of the cash register operators. The cash register operator's name is used to create a numeric password to logon and operate the cash registers.

(2) Briefly describe the privacy risks associated with the PII collected and how these risks are addressed to safeguard privacy.

The privacy risks associated with the PII collection are unauthorized access, inaccurate information in the system, and unauthorized disclosure of PII. There are security measures in place to mitigate these risks.
